2. Collection, Storage and Erasure of Personal Data as well as Type and Purpose and their use

a) When visiting the website:

This information will be temporarily stored in a so-called log file. The following information will be recorded without your intervention and stored until automated deletion.

- IP address of the requesting computer,
- date and time of access,
- name and URL of the file accessed,
- website from which access has been made (Referrer-URL),
- the browser used and, if applicable, your computer's operating system, and your access provider's name.

We use the services of the homepage provider Wix.com Ltd., Namal 40, 6350671 Tel Aviv, Israel to provide our website. Hereafter referred to as "Wix.com". Wix.com is based in Europe at: Wix.com Luxembourg Sarl, 5 rue Guillaume Kroll, L - 1882, Luxembourg

We are therefore users of Wix.com. When you visit our website, you are a "user of users" for the purposes of Wix.com. The processing of your personal data when you visit our website at Wix.com takes place exclusively on our behalf and only for the following purposes:

3. Disclosure of Data to Third Parties

Your personal data will not be transmitted to third parties for purposes other than those listed below. We only pass on your personal data to third parties:

4. Cookies

We use cookies on our website. These are small files that your browser automatically creates and that are stored on your device (laptop, tablet, smartphone, etc.) when you visit our site. Cookies do not harm your device, do not contain viruses, Trojans or other malicious software.

6. Rights of Data Subjects

You have the right:

- to obtain access to your personal data processed by us in accordance with GDPR sec. 15. In particular, you may obtain access

 or will be disclosed, the envisaged storage period, the existence of a right to rectification, erasure, restriction of processing
 or objection, the existence of a right to lodge a complaint, the source of your data, if these have not been collected by us,
 and the existence of automated decision-making including profiling and, if applicable, meaningful information on their
 details;
- to immediately request the rectification of inaccurate or completion of incomplete personal data stored by us in accordance with GDPR sec. 16;
